**IDHHC Strategic Plan** 

The Commissioners are aware of the national interpreter shortage and has made it a goal in its new 5-year Strategic Plan for July 1, 2024 – June 30, 2029. There was talk of the Minnesota's Interpreting Forward 2030 Project and whether IDHHC could do something similar. The Board expressed concerns related to the barriers to Deaf Faculty and certified teachers, ITP curriculums doesn't support passing the certification test, only educational requirement to licensure is high school diploma, individuals of color do not have access to interpreter training programs and whether an expedited process similar to teacher certification can be explored.

## **Interpreter Coordinator Report**

Tonia Bogener presented the Interpreter Coordinator report:

- The new Interpreter Coordinator, Will Lee, started on June 17, 2024.
- Welcome to Desa Walls who was recently appointed to the Illinois Board for Interpreters. There
  are still two board members serving on expired terms. IDHHC will continue with recruitment for
  new members.
- The 2024 Interpreter Professional Development series is currently underway. The workshops are posted on the IDHHC website. A total of 5 BEI Prep Workshops including both Advanced and Master Performance Test and 19 other workshops including but not limited to health care interpreting and Legal Interpreting, Ethics, Deaf Flavor and Unity in the Community. Over 115 hours of continuing education provided including the BEI prep workshops.

- Estimated expenditures for Fiscal Year 2024 Budget for Fund 449. Currently, no expenditures for the ISBE Grant Fund 405 as the workshop sessions hosted from July -August. Fiscal Year 2025 Budget for Fund 449 has been approved. The application is pending for the 2025-2026 ISBE Grant.
- IDHHC is experience an increase in out-of-state testers. This is likely due to Missouri and
  Wisconsin not testing while their BEI contract is in process of being renewed with Texas.
  IDHHC is working to renew the BEI Rating Contract with Texas to provide rating services for
  Master Level Exams or when the Illinois rating teams have a conflict of interest in rating a
  candidate.
- Will Lee, Interpreter Coordinator, is excited to join the team. His goals are to increase transparency regarding data and improve the overall functionality of the testing process.

### **Old Business**

Although not on the agenda, Board members inquired on the status of providing Deaf Interpreter Training. IDHHC recognizes the need to host the training to increase the pool of Deaf Licensed Sign Language Interpreters.
